1 Minutes of previous meeting- 24 May 2018

1.1 Matters Arising from the minutes

2019 Courses

The list of networks of expertise have been released by the MoE. Danielle has pointed out that there are networks on the list that have been granted courses by TRCC: Digital, Menza, Name. These groups will be double dipping with ministry funding.

Karina reminded the committee that this information was not available when the committee needed to make decisions about the 2019 courses.

Serena said that most of the associations tailor for the secondary sector, this is where TRCC can step in to help tailor for the primary sector. The courses we have are cross sector. Danielle raised the possible issue of associations offering PLD similar to TRCC and that would affect the uptake of registrations.

Kathryn pressed on to keep the courses selected by the Committee and deal with them case by case.

Promoting of courses

Anthony asked about promoting the courses in the Gazette. Eseta responded that post surveys indicated that Gazette and Eduvac are not the preferred means of finding out about courses. Approximately 2 participants from five courses preferred to find out about courses through Gazette and Eduvac. At present the courses are promoted with bulk emails, Eduvac, website, through the subject associations, and facebook. Anthony asked to continue to use Gazette as he believes there are a substantial number that read the Gazette.

Serena suggested with the new facebook page live this is an opportunity to take photos at the courses to post. There is the issue of getting consent from participants. This can be covered in the liaison speech at the beginning of the course that photos will be taken and anyone wanting to opt out to see the liaison member or TRCC staff. It has been discussed in the past to include an opt out clause in the registration. This to date has not happened. -Serena left the meeting early.

2 Review of TRCC

2.1 Strategic Plan- Te Tiriti o Waitangi- Statement of Intent, Special General Meeting Anthony sent out a draft to the Committee with 3 versions:

Majority of committee agree version C fits best with what would function well for TRCC. The wording 'will strive to have one tangata whenua representative' is accepted to show that this is a goal and rather than a 'must'.

Chris Oaks reinforced the need to include the PLD chair or delegate to ensure there is always representation from the PLD committee. Serena has concerns the chair of the PLD committee will have an unreasonable workload. Kathryn thinks that with the two committees operating there will be a reduced number of meetings.

Catherine asked why was there an increase of governance meetings? Serena said this was due to the changeover of personnel. When this happened, it was discovered there were a few gaps in the constitution and rules. PLD committee will be talking to the unions.

Karina

There is no representative from the playcentre. Maybe Cathy can give some light on this.

There is an opportunity to change/ fix things in 6 months at the AGM if we don't quite get the rules right at the first Special General Meeting. The unions will decide who gets onto the governance committee. Chris O suggested for the Governance Committee will be moved at the Special General Meeting.

Motion to change wording on version c, reducing the Governance Committee from nine (9) to seven (7) persons and putting a semi colon between 'unions' and 'plus two representatives...'

TRCC are on the verge of getting the contract. It has been signed 21 months, commence 1

June 2018. Value of it is \$534,000. Karina, Kathryn, Anthony and Chris Oaks have been talking to the ministry. Chris Oaks handed out a brief from a meeting he had with Kathryn

There will be some synergies, but the roles will not work together all the time. The brief had some detail of what still needs to be done and how to get there. Chris O suggested Karina, Anthony, Kathryn and himself to continue with the work to get it up and running. Anyone else interested is most welcome to join in with this group. The question was posed- Who might be the selection panel? Kathryn mentioned that the

The numbers have not moved much since the last meeting. There is a real concern about meeting the target of 600 participants. One course has been deferred and this will affect the ministry target. The committee have asked what advertising has happened. Eseta listed: Eduvac, Facebook, Bulk email to subscribers (6400 teachers), links to Network associations. The Geography numbers are a worry. Eseta expressed that the GIS planners are confident the numbers rise through their networks. More advertising through the Gazette. Chris O asked if teachers are not signing up due to the travel subsidy numbers being lower. The planners of *Unlocking Teachers' Potential* are not able to defer the course to October 2019. They are looking at April 2019 in Auckland. This will take the 2019 courses to 13. TRCC need to alert the ministry that school budgets are very tight and the total participant numbers are down compared to this time of year 2017. Schools are over-loaded, and resources are stretched. The Contract budget and ministry targets have been the same since 2003. Meanwhile, costs continue to rise. TRCC will note that 795 attendee teachers last year were over 11 courses; this year there are only 10 courses.

3.2 2019 Course Selection

Eseta sent emails to all groups who submitted ideas and proposals. All successful applicants have responded. There were some disappointed responses from unsuccessful groups. HATA applicant rang Eseta and was very upset as this will mean their conference would not go ahead. HATA asked to be considered if any 2019 courses pull out.

There were some courses the committee wanted to see offered in 2019:

Primary Science – Jessie McKenzie has accepted to organise this course.

AP DP Training – Colleen Douglas has accepted to organise this course.

Alt Ed – AENZ are pleased and thankful to be asked to run this conference again.

Relational Leadership – Eseta is to make contact with Trevor Jeffries.

Serena suggested that if TRCC work with an association with a ministry grant, TRCC could consider reducing the funding eg. No honoraria or ask association to pay for half the course.

3.3 Course Director's Report for 'Finding A Place Here'

Diane Lawrence and Serena Lewis attended this course. The report statistics show positive shifts.

3.4 Graphic Designer for flyers

Course flyers have historically been created by TRCC staff or course planners. There have been some comments that the flyers need to have a professional look. Eseta has Bunkhouse graphic designers to do this work. The first flyer made is for the Geography course in October. The committee like the flyer saying it looked fresh and professional.

Kathryn talked about the TRCC logo needing to be looked at again. The present TRCC logo doesn't reflect what TRCC do/represent.

Serena suggested this could be a competition for schools/ centres. Maybe with the Hub (NoE) this may be the time to get a new brand, especially with the new website.

Catha shared that He Whānau Manaaki have recently rebranded. Glass Tower Graphic Designers helped to support He Whānau Manaaki with this process. The rebrand included signs, flyers, letter heads, etc.

Chris O reminded the members that this presently is not part of the workplan for 2018. The branding can be looked at after the website and Arlo are set up. Chris Winstanley knows of other means to get money. We can ask for her help with this.

The initial cost for the flyer template was \$950.00 excl. GST. Each new flyer per A4 double sided (flyer+programme) will cost \$380.00 excl. GST.

Penny asked when did the bulk email go out. Eseta responded it should have been gone out yesterday. Anyware send out bulk emails for TRCC.

Shirley's hourly rate

Shirley was offered \$30 an hour. She has come back with wanting \$40 an hour. Karina asked how the rates were decided? Anthony and Kirsty discussed this and agreed that this was reasonable as she would be giving up work at PPTA to work for TRCC. Karina suggested that this topic needs to be discussed in-committee. Chris M said that she knows this information as she has been involved with the conversation with Shirley. Chris O agrees that TRCC need to make it worth her while to work for TRCC. Karina asked if it was possible to have a secondment or pay Shirley as a contractor. Paul recommended the best fit would be as a fixed- term employee. Payment would include ACC, holiday pay and kiwisaver if requested.

Resolution: That Shirley be paid \$40 plus the cost of employment for the ten weeks.

David Laing has contacted TRCC to let us know his company will possibly put in a quote for the website. He is still trying to get the 3 quotes the committee have asked for. Karina asked why it has taken so long. The website work is urgent. This is a real concern. Serena suggested TRCC contact the guy from Christchurch to get a quote to do the website. Danielle said that we want someone who comes recommended. Eseta is to contact David again and express the committee's concern with the delay in getting the website development started. He is to give whatever quotes he has. Diane has offered support if Eseta needs help with some of this work. Eseta will make it a priority to contact him by any means possible.

6 General Business

6.1 Purchasing of new TRCC merchandise

TRCC have enough conference bags for the July courses, but will need to make an order for the October courses. The bags cost about \$8 per bag. Eseta shared a range of bags with quotes for the committee to consider. Bags ordered in 2017 cost \$11,000. Funds used for bags could be used for the courses.

Karina asked the question: Do we need bags? What is their purpose? We need to be seen as sustainable. Having bags that are not reused is not sustainable.

There was a mixed response from members with their purpose. To have bags to carry a few items is not a good enough reason to keep buying them. Some members admitted they didn't reuse bags they received from courses they'd attended. The TRCC bags are strong and a good size for teachers to use. Is this a good enough reason to keep buying them? Are lanyards actually useful? Danielle and Kathryn shared they don't keep these. Serena and Diane like the lanyards for the committee as the pins from the name tags ruin their clothing. The lanyards would be better. Eseta thought these could be for participants too. Karina suggested stickers could be used instead. It was put to the committee again if merchandise is needed? Eseta will order a small number of lanyards for the committee. (Monnie leaves the meeting 5:50pm)

Instead of having printed copies of workbooks and resources, these course materials could be sent out digitally to participants. There can be a way to identify those who wish to have a hard copy of the resources. Diane expressed the need to remember there are a lot of ECE teachers who do not have access to these digital devices.
